

Hainan-exclusive Visa-free Entry Policy:

With the latest policy update, the number of countries benefiting from China's unilateral visa-free policy rises to 47. Combined with Hainan's 59-country visa-free entry policy, the reciprocal visa exemption agreements and other unilateral visa exemptions, a total of 85 countries now enjoy visa-free access to Hainan.

Appendix: Countries Eligible for Visa-Free Entry to Hainan

59 countries eligible for 30-day visa-free entry to Hainan (for tourism, business, exchanges and family visits, medical treatment, exhibitions, or sports competitions (excluding work and study)	18 countries with bilateral visa-exemption agreements not included in the 59 countries	8 countries with unilateral visa- free access not included in the 59 countries
